[Manhattan Jury Finds That Ed Sheeran Did Not Copy Marvin Gaye's 'Let's Get It On' >](#)

Last week, Ed Sheeran won his years-long copyright dispute with the heirs of Ed Townsend, who co-wrote the 1973 hit, *Let's Get It On*. A jury determined that Sheeran's Grammy award-winning song, *Thinking Out Loud*, did not infringe Marvin Gaye's soul classic.

In Case You Missed It

[FCA Confirms Test for Inducing Patent Infringement >](#)

In *Teva Canada Limited v. Janssen Inc.*, the Federal Court of Appeal confirmed that its previous decision in *Corlac Inc. v. Weatherford Canada Inc.*, did not change the test for patent infringement by inducement. To establish induced infringement, the patentee must prove that the alleged inducer influenced the direct infringer to the point that, without such encouragement, infringement would not have occurred.

[A New Era of Broadcast Regulation Begins: The *Online Streaming Act* Receives Royal Assent >](#)

On April 27, 2023, Bill C-11, also known as the *Online Streaming Act*, received royal assent, becoming law more than two years after the precursor Bill C-10 was tabled by the former Liberal government and died on the order paper, and after nearly 15 months of extensive parliamentary debate and public controversy. The *Online Streaming Act* serves as the most expansive refresh of the *Canadian Broadcasting Act* in over 30 years, responding to rapid technological change by providing, among other things, a framework for the regulation of online broadcasters, including online streaming platforms.

[The Competition Bureau Continues to Focus on the Online Marketplace >](#)

On April 17, 2023, the Competition Bureau released Volume 6 of the Deceptive Marketing Practices Digest, which gives insight into issues of concern for the Competition Bureau. Volume 6 focuses on two substantive issues in the online economy: fake scarcity cues and drip pricing.

[New Rules of Practice for Copyright Board of Canada Proceedings Are Now in Effect >](#)

On March 1, 2023, the Copyright Board of Canada published the final version of its Rules of Practice and Procedure in the Canada Gazette. The Rules, which are the Copyright Board's first time adopting formal rules of procedure, are now in effect.
